



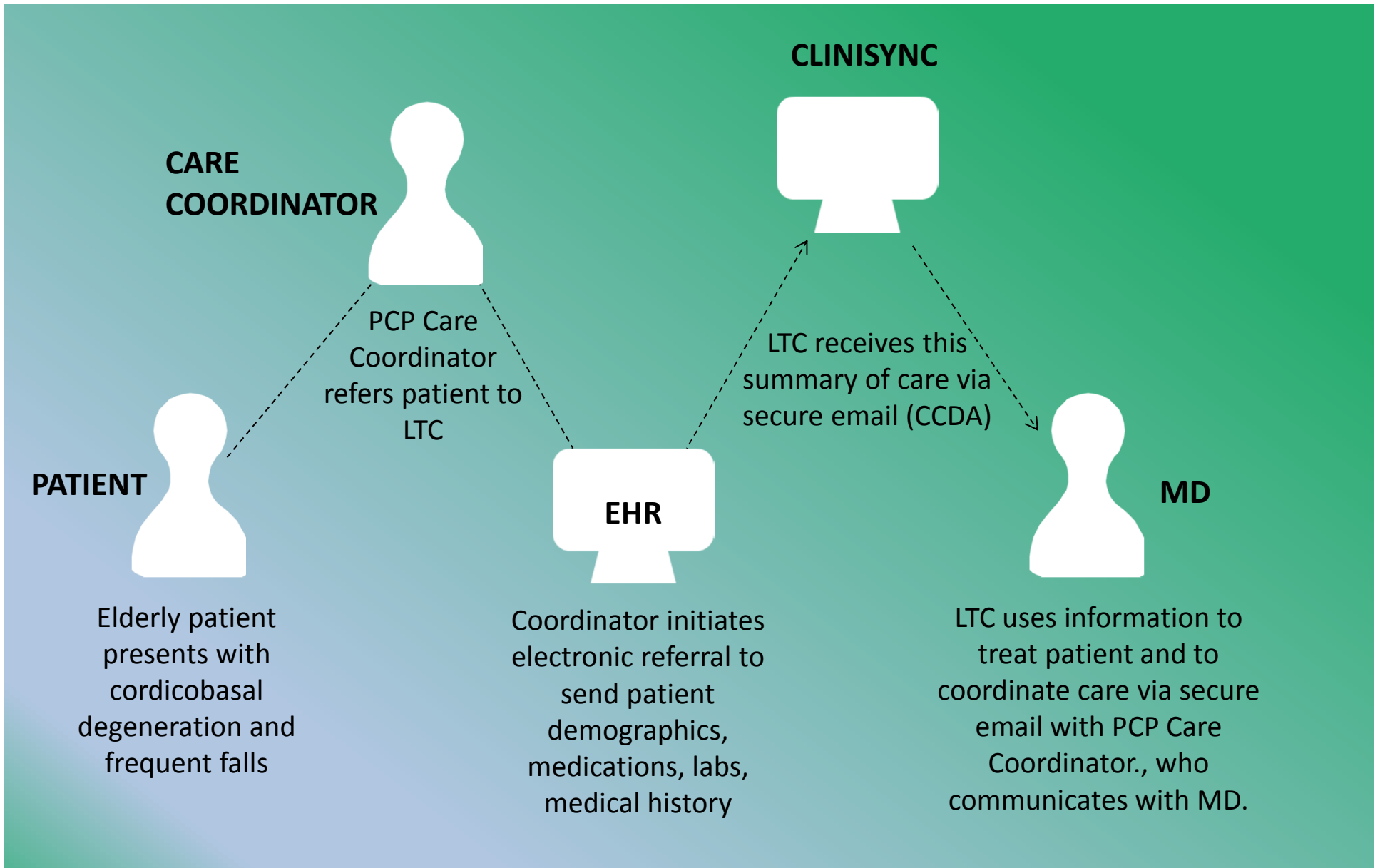

Care Coordination

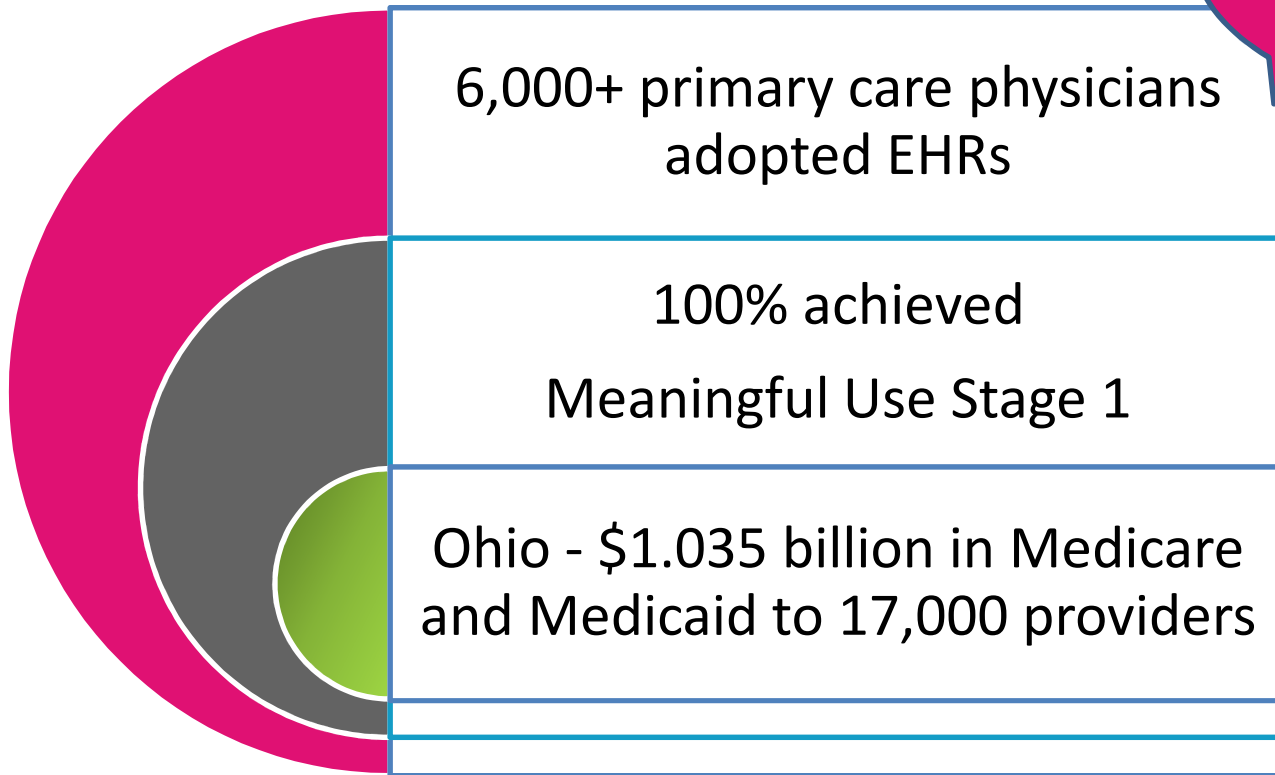

Information Exchange:

- 2015: Adopt a policy and technology allowing “Basic Choice”
- 2021: Move to “Granular Choice” allowing individuals to share specific types of information.

Transforming Clinical Practices Initiative: Ohio Practice Transformation Network

This OPTN proposal targets transformation of 6,400 Ohio clinicians with a \$28.6 million award, including more than 3,200 primary care and specialist clinicians in rural, small, independent and underserved practices.
